

1. DSS Medical Records Technical Documentation Manual

The FY2004 DSS Medical Record Book, technical documentation for the DSS National Data Extracts, was published in December 2003. It contains specific information on how DSS Medical encounter records are built for both inpatients and outpatients, and it will be useful to DSS users in identifying criteria to select DSS records of unique populations. 2. DSS SAS National Laboratory Results Data To Be Available for FY2001

The first DSS National Data Extract for laboratory results was done in August, 2003. Now all of 2003 and 2002 laboratory results are in the DSS SAS LAR files in Austin. DSS plans to make FY2001 lab results data in March 2004. The availability of three years of national lab results data will facilitate longitudinal research. 3. New HIPAA Privacy Rule Information for Clinical Researchers

The American Medical Informatics Association (AMIA) has announced its 2004 Spring Congress conference "Practical Strategies for Implementing Electronic Health Records," April 28-29, 2004, in the metropolitan Washington, DC, area. The conference has been developed to assist healthcare executives, senior managers, and implementation teams who are currently implementing, or soon will be implementing, electronic health record (EHR) systems.
